Successful planning service



- 3 components:
 - visionary plan-making which sets out the policies and proposals for the area;
 - efficient and effective development management, which applies those local and national policies in the determination of planning applications; and
 - well-resourced and effective enforcement

Extract from NAPE (National Association of Planning Enforcement)
Planning Enforcement Handbook for England



Paragraph 59 of the National Planning Policy Framework (NPPF) July 2021 says:

Effective enforcement is important to maintain public confidence in the planning system. Enforcement action is discretionary, and local planning authorities should act proportionately in responding to suspected breaches of planning control. They should consider publishing a local enforcement plan to manage enforcement proactively, in a way that is appropriate to their area. This should set out how they will monitor the implementation of planning permissions, investigate alleged cases of unauthorised development and take action where appropriate.

- Fines (varying amounts £1,000, £2,500, £5,000 but also unlimited)
- Proceeds of Crime - confiscation orders will ordinarily match the value of receipts (not profit) arising from criminal offending, the sums involved can become substantial
- Imprisonment

Why is effective enforcement important? (NPPG)



- Effective enforcement is important to:
 - tackle breaches of planning control which would otherwise have unacceptable impact on the amenity of the area;
 - maintain the integrity of the decision-making process;
 - help ensure that public acceptance of the decision-making process is maintained.

Team can investigate:



- development consisting the change of use of land/buildings without planning consent
- works to listed buildings without consent
- any activity giving rise to direct or indirect damage to protected trees or qualifying trees in conservation areas
- non-compliance with conditions attached to planning permissions
- unauthorised building works and/or engineering works
- display of unlawful advertisements
- untidy rear gardens

Team can't investigate:



- boundary wall disputes and other land ownership issues as these are civil matters outside of the planning legislation
- legal covenants
- devaluation of property
- obstructions, parking and traffic enforcement*
- graffiti and anti-social behaviour*
- dangerous structures*
- noise nuisance*

* = this is covered by other GBC teams (and of course Kent Police etc have own powers)

Enforcement investigation process (simplified)



- Step 1 – Complaint received of potential planning breach
- Step 2 – Preliminary checks
- Step 3 – Investigation required (yes (case opened) or no)
- Step 4 – Investigation underway
- Step 5 – Breach identified (yes or no (case closed))
- Step 6 – Work to find appropriate outcome - depends on harm being caused by the breach
- Step 7 – Successful outcome? (yes or no (case closed))
- Step 8 – Consider expediency of formal action
- Step 9 – Formal action undertaken
- Step 10 – Successful appeal (no or yes (case closed))
- Step 11 – Monitor compliance (yes (case closed) or no (back to step 8))

Need for effective communication



- Effective enforcement action relies on accurate information about an alleged breach of planning control.
- Complainants will only provide information if they feel safe to do so and see the value of reporting potential breaches
- Need for timely progress updates to complainant and publicising positive outcomes
