### 69. Licensing Act 2003 - Revision of Statement of Licensing Policy

The Regulatory Services Manager reminded Members that, at its meeting on 8 December 2015, Full Council approved a 'no-casinos' resolution as allowed under Section 166 of the Gambling Act 2005. On 18 December 2018, Council will need to decide whether to ratify the 'no-casinos' resolution for a further three years so that it can be included in the new policy.

**Resolved** that:

- The Committee noted the recommendations shown in Appendix 3 to the report and recommended that these be incorporated in the Statement of Licensing Policy to be put before the Council for approval on 18 December 2018
- The Committee recommended that Full Council ratify the existing no-casinos resolution for a further three years.
